At the earliest opportunity, I will

- **record research titles to students on a 1st come 1st served basis,**
- **confirm by return that your choice has been recorded,**
- **advise the staff proposer that you have chosen the title and**
- **amend the public record on a daily basis.**

Please note that additional titles will be added to the list as they become available, so **always consult the current list before choosing.**

The aim is to ensure that every student has selected a topic, has made contact with their supervisor before the commencement of the Christmas Break, and that as Course Leader, I have a record of each student's assignment to ensure smooth running of and administrative support for the Course.

Once your title has been confirmed, introduce yourself to the relevant supervisor, stating that you would like to undertake your chosen piece of research under their supervision. If after preliminary discussions the supervisor accepts your application, make arrangements for supervision and proceed with your research.

If you fail to secure supervision on that topic, you will need to make an alternative selection and proceed again as outlined above.
