

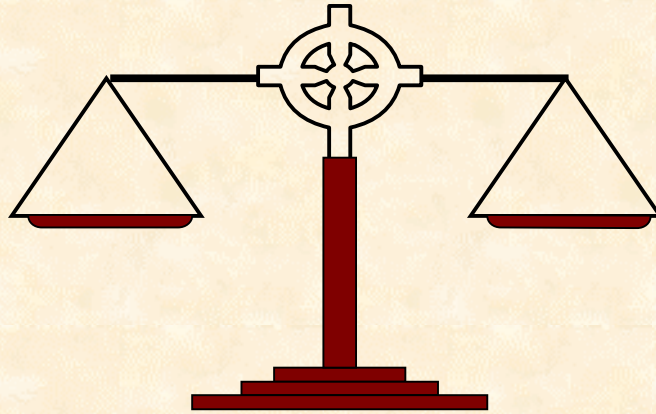

## INTRODUCTION TO MEMBERSHIP OF NADR AND NMA

NADR is an alternative dispute resolution service provider of private adjudication, arbitration and mediation services to the international community. NADR is an adjudicator, arbitrator and mediator appointing body NADR affording appropriately qualified individuals the opportunity, as listed members and fellows of the academy, to engage in global ADR practice. NADR membership is not mutually exclusive of other ADR organisations. Members are encouraged to qualify for and become practicing members of relevant professional bodies and ADR service providing Institutes and Associations. Applications for membership from individuals already qualified for ADR practice with other recognised professional bodies, Institutes and Associations are welcomed and encouraged.

As a dispute resolution systems provider NADR seeks to strike a balance between the requirements of expert guidance and decision making, justice, fairness and impartiality.



The NADR scales symbolise that balancing process and sets the standard for what is expected of NADR ADR practitioners.

s1 Arbitration Act 1996 of England and Wales states that the object of arbitration is to obtain the fair resolution of disputes by an impartial tribunal without unnecessary delay or expense and that the parties should be free to agree how their disputes are to be resolved without undue interference by the courts. s33 of the Act further requires that each party be afforded a reasonable opportunity to put his case and deal with that of his opponent.

A fair resolution involves the tribunal in adopting procedures that avoid unnecessary delay and expense. s1 Civil Procedure Rules 1998 of England and Wales defines justice in terms of equality between the parties and the expeditious settlement of disputes at a cost proportionate to the amount of money involved, the financial position of each party, and the importance and complexity of the dispute. Similar sentiments can be found in the law reports and legislatures from around the world. Mediation whilst currently unregulated by law in England and Wales must likewise be cost effective, fair and impartial if it is to serve any useful purpose.

The NADR scales are not held in the hand of a supreme being representing the majesty of the law. NADR is neither blindfolded nor all seeing. Justice under NADR is based on the co-operation of the parties and the professionalism and expertise of NADR's practitioners. NADR is a private company, which provides a service to volunteers seeking a balanced alternative to the judicial systems of states. The scale is NADR's guarantee that NADR carefully weighs the competing needs of its clients on a finely honed fulcrum, to provide the fairest and most appropriate service possible in the light of all the circumstances surrounding each dispute submitted to it and the expectations of fairness of the parties involved in that dispute.

The NADR scales are technical in design symbolising the fact that NADR practitioners, drawn from social, commercial and industrial backgrounds, employ practical as well as legal expertise in the performance of their duties to clients.

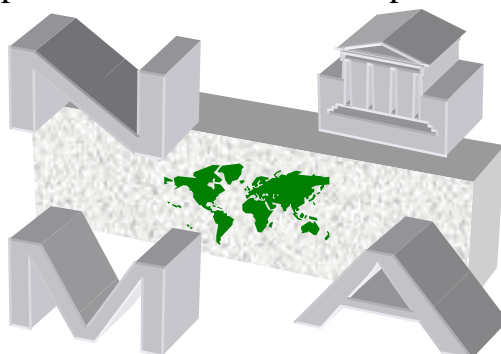

## **NADR GENERAL MEMBERSHIP RULES**

Let it be known that membership of NADR is as follows, subject to the Ethical Codes of Practice, Rules and Regulations of the Academy:

- 1 **Associate Membership** is available to persons who have satisfied the Board of Directors of NADR that, by the virtue of their calling, they are closely involved in dispute resolution processes and can through association with the Academy make a valuable contribution to society. Persons who have been awarded an ADR Attendance Certificate by the NMA may apply for Associate Membership.
- 2 **Membership** is available to persons who have satisfied the Board of Directors of NADR that they possess satisfactory levels of practical knowledge and skill in one or more fields of dispute resolution practice. Persons who have been awarded an ADR Certificate by the NMA may apply for Membership.
- 3 **Panel Listing** is available to those Members of the Academy who have successfully completed pupillage under the guidance of a senior NADR practitioner, whereby the Board of Directors of NADR deems that they have gained sufficient practical knowledge, skill and judgement in their field of ADR practice to be able to conduct an adjudication, arbitral tribunal, dispute revue process or mediation without supervision.
- 4 **Fellowship** is available to experienced ADR Practitioners who have satisfied the Board of Directors of NADR that they possess high levels of practical knowledge and skill in their field of ADR practice. Members who have attended advanced NMA training programs and successfully completed all program assessments may apply for Fellowship.
- 5 **Conversion Rules.** The Board of Directors of NADR reserves the right to award appropriate membership status and Panel Listing to applicants on the basis of prior learning, accreditation, certification and practice.
- 6 **Standards of Conduct.** Membership is conditional on adherence to the Ethical Codes of Practice, Rules and Regulations of the Academy. The Board of Directors of NADR reserves the right to withdraw membership status and panel listing from any person whom the Board<sup>1</sup> deems to have conducted themselves in a manner unbecoming of membership of the Academy.
- 7 **Benefits of Membership.** Members of NADR will be afforded a fair opportunity to participate in NADR dispute resolution processes at a level commensurate with their standing with the Academy. All Members of NADR will be entitled to attend NADR Conferences and Seminars at discount rates, to receive NADR Newsletters and the NADR Dispute Resolution Journal.

<sup>1</sup> See further NADR Disciplinary Rules and Regulations. No sanction will be made against a member without the member having first been afforded, where practicable, the opportunity to attend a full and complete hearing before the NADR Disciplinary Panel. The Disciplinary Panel will not usually consider complaints by the parties to a dispute being handled by a member in the absence of a challenge to the outcome of that dispute by the Courts and a ruling by the Court that the member had acted in an unlawful or wholly inappropriate manner.

## NADR PANEL LISTING and NOMINATION RULES

- 1 **Panel Listing.** A member of the Academy who has successfully completed pupillage, whereby the NADR Board of Directors deems that that member has gained sufficient practical knowledge, skill and judgement in their field of practice to be able to conduct an adjudication, arbitral tribunal, dispute review process or mediation without supervision may be enrolled upon the panel listing members of the Academy eligible for nomination for practice by the nominating officer.
- 2 **Practicing Certificates.** Listed Members & Fellows will receive a Practice Certificate in respect of the level of and area of practice and expertise that that member is eligible to be nominated for by NADR in any given year. The certificate will record that the member is either a Listed Member or Listed Fellow. The level of practice relates to the entitlement to adjudicate, arbitrate and or mediate. The area of expertise relates to the relevant technical and vocational qualifications of the member. The certificate will acknowledge the status of the member one calendar month prior to the date of issue. Upon application, amended certificates will be issued, where applicable, to indicate more recent achievements.
- 3 **Purpose of Listing.** Listed members will be afforded a fair opportunity to participate in NADR dispute resolution processes at a level commensurate with their standing with the Academy. All NADR nominations will be made by the NADR nominating officer. Where applicable, final selection may be made by the parties to a dispute from a short list provided by the nominating officer. Listed Members may be placed on a short list for party selection. Nothing in these rules detracts from the residual powers of the courts in appropriate circumstances to appoint any adjudicator or arbitrator to a dispute.
- 4 **Listed Members.** Listed Members may be nominated by NADR to serve as an adjudicator, arbitrator or mediator in respect of disputes from time to time subject to NADR dispute settlement procedures, subject to The NADR Rules of Practice. Members are entitled to decline a nomination.
- 5 **Listed Fellows.** Listed Fellows may be nominated by NADR to serve as a senior adjudicator, arbitrator or mediator in respect of disputes from time to time subject to NADR dispute settlement procedures, subject to The NADR Rules of Practice. Members are entitled to decline a nomination.
- 6 **Insurance.** Panel listed members must carry Professional Indemnity Insurance. NADR does not provide general professional indemnity insurance for members.
- 7 **Independent Practice.** The Academy accepts no responsibility or liability for the conduct of members acting independently of NADR. These rules do not apply to ADR processes conducted by members outside NADR's spheres of influence.
- 8 **Cessation of Membership.** Upon cessation of membership or in the event of the member suffering any disqualification or impediment disbarring that member from practice, the member must remove the Practice Certificate from public display and return it immediately to the Academy.

## GENERAL ARBITRATION MEMBERSHIP RULES

In addition to the general rules of membership, membership of the NADR for the purposes of arbitration practice is as follows :

- 1 **Associate Membership** : Legal Practitioners and other professionals with a certified qualification in Legal Systems, the Law of Tort and the Law of Contract, who have been awarded an Arbitration Attendance Certificate by the NMA or have successfully undertaken the NMA Legal Foundation Courses, may apply for Associate Membership.
- 2 **Membership** : Persons with relevant specialist skill / knowledge who have been awarded NMA Certificates of Competence in one or more areas of Subject Specialist Arbitration Practice or Public International Arbitration Law and Practice plus The Substantive and Procedural Law of Arbitration, International Arbitration Law and Practice, and Arbitral Practice 1-5 or equivalent, may apply for Membership. The Membership certificate will indicate areas of subject expertise.
- 3 **Fellowship** is available to experienced Arbitrators and Adjudicators who have satisfied the Board that they possess high levels of practical knowledge and skill in their field. Members who have attended advanced NMA training programs and successfully completed all program assessments, in particular the 40 hour Arbitral Hearing and Award Writing program plus Arbitral Practice 5, may apply for Fellowship. The Fellowship Certificate will indicate areas of subject expertise.
- 4 **Panel Listing** is available to those Members of the Academy who have successfully completed pupillage under the guidance of a senior NADR practitioner, whereby the interview panel of the Board deems that they have gained sufficient practical knowledge, skill and judgement in their field of Arbitral practice to be able to conduct an adjudication, arbitral tribunal, or dispute review process without supervision. - 4 **Panel Listing** is available to those Members of the Academy who have successfully completed pupillage under the guidance of a senior NADR practitioner, whereby the interview panel of the Board deems that they have gained sufficient practical knowledge, skill and judgement in their field of Adjudication practice to be able to conduct an adjudication without supervision. Progress through the qualifying Professional Development Program must be charted by the applicant in his or her NADR Record of Achievement Portfolio and verified by his / her pupil master. Panel listing is by subject expertise.
- 5 **Conversion Rules.** The NADR Board reserves the right to award appropriate membership status and Panel Listing to applicants on the basis of prior learning, accreditation, certification and practice. A familiarisation course in respect of NADR procedures may be mandated at the Board's discretion. Attendance before the interview panel of the Board may also be required. ## GENERAL MEDIATION MEMBERSHIP RULES

Panel listing is by subject expertise.

## 40 HOUR NMA ARBITRATION TRAINING COURSES

- 7 Arbitral Practice 2.** Case management, Interim Awards, Orders and Directions and Award Writing.
- 8 Arbitral Practice 3** Representing a client at arbitration, client interviewing skills, record taking, progressing a case, attendance at hearings (preliminary and final), pleadings, evidence, expert witness skills and cross questioning for party representatives.
- 9 Arbitral Practice 4.** Challenging and enforcing arbitration awards. New York Convention on the enforcement of arbitral awards – judicial review and appeals procedure. Ethics and good practice.

- 11 Subject Specialisms.** All arbitrators are listed by specialisms. In the absence of legal expertise in a specific area of expertise, a specialist course must be successfully undertaken for diploma certification.
